



CALL FOR PROPOSALS
2023 Research Grant (up to \$1000)
Submission Deadline: January 15, 2023

Eligibility:

All applicants must be current members of the Council for the Study of Community Colleges (CSCC) at the time of submission and have not received a research grant from CSCC in the last five years.

Evaluation Criteria:

- Project contributes to the professional body of knowledge about community colleges, including, but not limited to, community college teaching and learning; leadership; administration; policy; student success; campus climate; diversity, equity, inclusion, and accessibility; international issues; governance and finance.
- Potential for the project to contribute to practice within community colleges.
- Proposal quality, including clarity of information provided including, knowledge of relevant and recent literature; appropriateness of research methodology with adequate details of research methods and procedures; feasibility of the timeline; adequacy of budget to support project expenses.

Award Recipients are Required to:

- Submit a copy of their institution's human subject approval, if applicable.
- Provide the CSCC Vice President of Research and Publications with a copy of a resulting research report and/or drafted manuscript for publication that is based upon the funded research project. This must be submitted within two years of the receipt of the award. This document will be maintained as a permanent record of the Council's activities and may be posted on the CSCC website.
- Acknowledge support from CSCC in publications that result from the funded research project.
- Present at the 2024 CSCC annual conference.

Award recipients will be announced during the Annual CSCC Conference, which will be held on April 20- April 22, 2023.
